In consideration of Purchaser's delivery to Builder of a non-refundable deposit of \$\_\_\_\_\_, Builder hereby agrees to build exclusively for Purchaser a Trinkka 8 according to the specifications indicated by Purchaser on page 1, Trinkka 8 tinker (order) sheet, hereof for a total price of \$\_\_\_\_\_.

The balance of the purchase price over the above stated deposit shall be payable in full before delivery of the completed Trinkka 8 at Builder's place of business, Vero Beach, Florida. Delivery elsewhere other than Builder's place of business will be at Purchaser's expense on a C.O.D. basis.

Any changes to the specifications requested by Purchaser after the execution of this contract will necessitate an additional charge to Purchaser; to be determined by the Builder depending on the nature of the change and the stage of construction at which the changes are requested. No changes will be made unless agreed to by Purchaser and Builder in writing.

Purchaser shall be entitled to inspect construction of his/her Trinkka 8 during normal business hours at Builder's place of business, in person or through any duly appointed representative.

This written contract (pages 1 and 2) contains the entire agreement between Purchaser and Builder and no oral representations or agreements shall be binding on either party.

BUILDER WARRANTS THE TRINKKA 8 BUILT PURSUANT TO THIS CONTRACT FOR A PERIOD OF 10 YEARS AGAINST ANY DEFECT IN WORKMANSHIP OR MATERIALS SUPPLIED BY THE BUILDER. THIS WARRANTY DOES NOT COVER PARTS MANUFACTURED BY ANY OTHER PARTY THAN THE BUILDER AND EXCLUDES ANY RESULTING OR CONSEQUENTIAL DAMAGES. WARRANTY IS LIMITED TO THE VALUE OF REPLACEMENT OF ANY DEFECTIVE PART.
